- No entries accepted without alternate frequencies ,except 2.4
- Open water is Friday, June 25th, 12:00 pm – 6:00 pm
- Minimum entry of three (3) boats to make a class. All three (3) boats must start at least one (1) heat
- Awards for 1st, 2nd, 3rd, concourse, and High Point winner
- Maximum of 200 entries
- Drivers meeting 7:30 am Saturday and Sunday
- Four (4) rounds to be held – time permitting
- NO ALCOHOLIC beverages allowed
- NO overnight camping at Park (Other Camp Site Available)
- On-site security Friday & Saturday night
- 1/8 scale races under standard heat racing rules
